

(57) Abstract: The present invention relates to the microbial delivery of obesity related peptides. More specifically, the invention relates to the use of genetically modified yeasts and/or lactic acid bacteria for the delivery of neuropeptides and/or peptide hormones that play a role in stimulation or inhibition of food intake and/or energy homeostasis.
